

As we observe our 35th anniversary this year, A Safe Place looks back to its beginnings when five women lawyers formed the Nantucket Women’s Bar Association with the top priority of setting up a rape and abuse network and an advisory board.

Sarah Alger, Julie Fitzgerald, Sara Greenberg, Melissa Philbrick, and Rhoda Weinman scheduled their first public meeting on February 17, 1987, with an agenda formed by their own experiences, which Weinman describes as having nowhere to send clients who had experienced domestic violence or sexual assault.

A Safe Place in 2022 salutes these founding women for taking action to address the continuing serious problem of domestic violence and sexual assault on Nantucket. Many islanders, serving as directors, staff, and volunteers, have followed in their footsteps. Thanks to their efforts, 35 years later the organization has a strong presence on the island and offers an expanding range of both supportive and preventative programs and services to all members of the Nantucket community.

FROM THE EXECUTIVE DIRECTOR

I am excited to share what a momentous year this is for A Safe Place. As an organization we are currently celebrating our 35th anniversary of being in operation. Additionally, I am proud to say that August just marked my 15th anniversary working to support survivors through this wonderful organization. I have held multiple roles within A Safe Place and have seen tremendous growth in the programs, services, and staffing levels provided to the community. In reflection, I never thought I would be working here for this length of time, but the mission really became a huge part of who I am and, thus, kept me working to support survivors, the staff team, and the overall organization. We have new dreams for A Safe Place, and I am excited to continue working on these dreams for many years to come.



I want to thank you for being a part of our past and hope that you will stay by our side moving into the future. We have come a long way, but we still have a lot of work ahead of us. Since the pandemic began, our numbers have continued to rise in terms of the number of survivors that we have served. In fact, we have seen a 12% increase in our Trauma Therapy program in comparison to last year, a 25-30% increase in both our Domestic Violence and Rape Crisis programs that has remained at this heightened level since before COVID, and more than 150% increase in our Supervised Visitation program since last year. This is alarming, but we are happy that our services exist and that we have been able to meet this increased need.

We have had a successful year and I owe that to you-our donors, supporters, volunteers, and friends. Please know that I recognize the greatness that you bring to A Safe Place...each kind note, financial donation, in-kind donation, show of support at an event, or volunteer hour really does make a difference. Thank you from the bottom of my heart. I look forward to our continued work together.





START BY BELIEVING

Senior Advocate, Frejae Burrows, and Executive Director, Jennifer Frazee, attended the annual End Violence Against Women International (EVAWI) conference in San Francisco. Through this conference they became familiar with the **Start By Believing** campaign, a global campaign meant to transform the way we respond to sexual assault.

The campaign encourages individuals to respond to disclosures of sexual assault by assuming the survivor is telling the truth and believing them. Too many survivors receive negative responses in the aftermath of sexual assault and are questioned for their choices or behaviors. These negative responses can worsen the survivor's trauma.

Start By Believing aims at stopping this cycle by improving the personal and professional reactions of others. The message is simple yet powerful. Let us work together to **Start By Believing**.


